Hazard: The use of Volunteers – Litter Picking

What is the Risk? Volunteers working on the side of the Highway; Risk to Pedestrians from trips, strains to volunteers or falls; injury from sharps & contamination from animal faeces.

What is the Benefit? Individuals protected/ property protected.

What steps need to be taken to reduce the risk to an acceptable level?

- 1. High Visibility Vests to be worn by all Volunteers & Councillors when working at the side of the Highway (recommendation of Insurance provider)
- 2. Sturdy Shoes & Appropriate clothing for weather conditions (waterproof jacket), long sleeves & long trousers
- 3. Drinking Water
- 4. Mobile phone to contact co-ordinator, Councillor Harden, if necessary.
- 5. Protect any cuts with waterproof plasters
- 6. Avoid rubbing the mouth & eye area while working
- 7. Wash hands & forearms before eating, drinking, smoking, using the toilet
- 8. Working in pairs or groups
- 9. Due to the nature of the highway, no earphones for iPod or such to be used in order that volunteers can hear approaching traffic
- 10. On Main Roads litter pick on pavements only
- 11. Village Lanes with no pavements signs to be placed around the areas to be worked warning motorists of the activity in order to protect works (Organisers to provide signs)

<u>Hazardous Items</u> - **DO NOT PICK THEM UP**, report to your Co-ordinator or to be moved by litter pickers **ONLY** into the hedgerows:

- 1. Any 'sharps', i.e. knives, syringes, needles
- 2. Unidentified drums, cans or canisters

- 3. Poisons, insecticides
- 4. Clinical Waste
- 5. Broken Glass
- 6. Condoms
- 7. Other hazardous substances (e.g. suspected asbestos)
- 8. Any dog or animal faeces to be left in situ to allow it to degrade

DO NOT LITTER PICK:

- 1. Near unstable banks of ditches/ponds or any boggy wet areas
- 2. Near electric fences (identified by yellow warning signs)
- 3. In streams, bodies of water (risk of catching leptospirosis from water contaminated by rat's urine)
- 4. On private land, building sites or business premises

Further Safety Notes:

- 1. Use the loaned litter sticks only to prevent injuries by bending excessively
- 2. Only carry a manageable weight in the bin bag
- 3. Do not lift large/heavy/awkward items (contact your co-ordinator)
- 4. All equipment and refuse bags to be kept out of traffic and pedestrians' way
- 5. All volunteers to be appropriately trained & covered by Tetford & Salmonby Parish Council insurance policy
